SUPERVISOR'S REMARKS

The Kendall Town Board has begun the 2025 Budget Process. We anticipate higher expenses across all departments. We will work diligently to maintain our current tax rate. We will try to remain under the tax cap, even though we have many budgetary issues facing us. We're up to the challenge.

The Town of Kendall has the lowest tax rate in Orleans County.

Ambulance service costs and medical coverage costs are unknown at this point.

Sewer District:

We continue to make progress on our sewer project while fulfilling several obligations to New York State Parks as well as Monroe County. Still a lot of work needs to be completed prior to going out to bid.

The August 20, 2024 minutes were accepted, as presented.

PUBLIC COMMENT

Truda Slocum, Lakeshore Road – asked for an update on the grant that Senator Schumer's office has considered for the Town of Kendall for Water District Eleven.

Supervisor Cammarata said it has "gone to committee" for decision. Although it is not a sure thing, there is reason to be very optimistic.

John Gainer, Bald Eagle Drive – asked where the sewer project will begin.

Supervisor Cammarata responded that we will not know that until an eventual contractor is hired. Mr. Gainer and his neighbors want to prepare for the construction mess on their properties. Supervisor Cammarata provided a rough timeline. Bids may be solicited as early as December, and

ground work may begin as early as Spring of 2025.

Lights for the flags in the cemeteries have been ordered.

The highway buildings need foundation and ventilation work, if ARPA funds are available for that, or grants.

Community Relations – Flow – Scarecrow Festival October 5th, and Farmers' Market Culture & Recreation – Flow – The ONLY current park owned by the Town is Lakeview Park on Thompson Drive, which was paid through grants. There is some confusion that the Gazebo/Memorial Park is owned by the Town. It is not. It is owned by the school district. Curtis Park has been donated to the Town, with the stipulation that it will be used as a park permanently.

Deferred Compensation program is available to employees. The full time highway workers have had a meeting. The other full time employees, such as the Assessor, will be notified as to the program.

Planning, Zoning & Agriculture – Jennings/Bentley

The current zoning codes for accessory structures at the lakefront are being looked into, as property sizes were not taken into account when they were drafted. Livestock ownership at the lakefront properties has been reported. That is against the current code. Roosters have been relocated from one address.

Finance, Taxes & Special Districts – Cammarata – Budget work continues

Orleans County Legislature – John Fitzak

The designation of "sanctuary status" for lakefront property is being looked into.

There could be ramifications to that designation as far as what may be allowed, so caution is advised.

Budget work is grueling this year. The NYS unfunded mandates are causing quite deep cuts elsewhere, in order to remain under the tax cap.

The NYS and Federal grant procurement rules are changing and becoming much more cumbersome.
