RESOLUTIONS

Councilwoman Flow made the following motion, which was seconded by Councilman Bentley.

RESOLUTION 99-1224 ACCEPTING TOWN COUNCILMAN PAUL JENNINGS' RESIGNATION

Whereas, Councilman Jennings has tendered his resignation to the Town Clerk, so therefore,

Be It Resolved, that the Kendall Town Board does accept, with regret, Dr. Jennings' resignation, which will be effective December 31, 2024, and does thank him for his dedicated work and guidance during his years of public service on this Town Board, and does wish him well in all of his future plans.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilman Bentley made the following motion, which was seconded by Councilman Martin:

RESOLUTION 100-1224 AGREEMENT FOR RUGS AT KENDALL TOWN HALL

Whereas, it is the obligation of the Kendall Town Board to maintain and preserve the buildings and grounds, and it has been determined that the floor of the lobby of the Town Hall does require protection from foot traffic and salt,

Be it Resoved, the Kendall Town Board agree to a three year contract with ALSCO UNIFORMS, 548 St. Paul Street, Rochester, N.Y. 14605 to provide the following carpets: (5), 3 x 10, Mat, [1], 3 x 5, Mat, and [1], 4 x 8, Mat. The weekly cost of \$38.29.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Supervisor Cammarata made the following motion, which was seconded by Councilwoman Flow:

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilman Martin made a motion to accept the claims as presented:

Motion was seconded by Councilman Jennings. Vote resulted in all ayes.

Councilman Martin recommended that the purchase limits at which bids are required be changed to reflect current pricing of goods and services. All were in agreement that it will be addressed at the next meeting.

Supervisor Cammarata recommended that our prices for graves and interments be raised.

Clerk Richardson recommended that all of the policies be reviewed during 2025.

Councilwoman Flow said that Co-Rec Director Werth is not seeking reappointment. Co-Director LaMay will now be Director.

Councilman Bentley stated that the decision to appoint Mr. Gaudioso to replace Councilman Jennings has been done unilaterally, and did not include the Town Board as a whole. He does not have an issue with the choice, but does not believe this is being done in good order. Supervisor Cammarata defended his decision and choice, citing a need for an immediate replacement due to a vacancy causing an issue with raising a quorum throughout the winter. Councilman Bentley expressed that there was time to do the proper procedure.

A discussion was held as to whether a super majority is required to appoint a Councilperson to finish a term of an elected position. Supervisor Cammarata looked up and read the town law addressing this. A super majority is NOT required.

Councilman Martin requested that all keep him informed of issues as he spends the winter in Florida. He can still perform much of his responsibilities remotely. Clerk Richardson suggested he attend the board meetings via phone, so he can question any business he needs to, and give input.

Councilwoman Flow moved to adjourn. Councilman Bentley seconded that. All agreed. Meeting adjourned at 3:05 p.m.
